


SOLAR Sawnee EMC is proud to serve our members with a diversity of affordable and reliable resources. All the while offering environmentally responsible options such as solar energy to our members as part of our diverse portfolio. Over the past decade Sawnee EMC has purchased economically priced solar energy through sustainable, low risk solar generation projects benefitting both Sawnee EMC's members and the state of Georgia.

Sawnee EMC has procured approximately 111 MW of solar electricity for Sawnee EMC's members. These solar assets support Sawnee EMC's 2022 Solar Renewable Energy Credit Program and our Virtual Solar Program which was launched in 2018. The Virtual Solar Program allows members the opportunity to purchase solar power for an additional monthly rate in order to offset traditional electricity usage. With a focus on long term positive energy solutions, The Sawnee EMC Board of Directors seek to participate in solar projects that make long term business sense and energy security for our members.

RENEWABLE ENERGY CREDITS Many members are interested in renewable electricity to achieve their energy objectives. Sawnee EMC's Solar Renewable Energy Credit program allows participating members to achieve these energy goals by helping to offset their environmental impact without having to install solar panels or other renewable energy systems. The program allows participating members to receive retired renewable energy credits from Sawnee's solar generation projects located in Georgia. While the credit is not equivalent to buying electricity, it represents and includes the clean energy attributes of renewable electricity.



EV's Electric vehicles can be a smart transportation choice for some members as they are becoming more and more popular. Nearly every manufacturer offers at least one model, and the technology continues to improve. EVs provide environmental benefits, lower operating costs, and a quiet, smooth and fun ride. Members contact Sawnee EMC's Energy Services Team each day for information regarding electric vehicles. After all, Sawnee EMC is your source of power and information, and electric vehicles are just one of the topics our staff is glad to have the opportunity to discuss with you. For electric vehicle owners or soon-to-be EV owners who want to build energy independence and save money, Sawnee

EMC currently offers a library of resources and tools online at [sawnee.com/plug-in-vehicles](https://www.sawnee.com/plug-in-vehicles) to help members learn more about EVs. Additionally, Sawnee EMC offers a \$250 rebate for members who have an electric vehicle, install a Level 2 charger and participate in a time of use incentive rate encouraging them to charge during off-peak hours.

FOUNDATION Sawnee EMC is dedicated to improving the quality of life for people in its service area. This is accomplished by providing affordable electric service, and also by our active involvement throughout the local communities we serve. From Holly Springs to Flowery Branch to Johns Creek, many organizations have benefitted from small donations made each month by our Operation Round Up participants.

The Sawnee Electric Membership Foundation is a 501(c) 3 organization which provides an avenue for members of Sawnee EMC to donate funds, through Operation Round Up, for charitable purposes. Local community leaders voluntarily serve on the Foundation Board of Directors. Since 2003, the Foundation has donated more than \$3.8 million back into local communities.

The Foundation has funded a multitude of community-based programs throughout the seven (7) counties served by Sawnee EMC. Grants have supported food banks and community health clinics, educational initiatives, emergency shelters, and more. Learn more at sawnee.com/oru.

SCHOLARSHIPS Helping today's students achieve their academic goals is a great investment in the future. Since 2006, the Sawnee Electric Membership Foundation has awarded over \$1 million in Youth Scholarships to students pursuing their secondary education. Additionally, the Sawnee Electric Membership Foundation supports men and women interested in pursuing a career as a lineworker through the Brian Johnson Memorial Scholarship. The recipients of both scholarships are dedicated to making a difference in the world around them and creating positive energy in their own way.



OPERATION ROUND UP A successful community development program, Operation Round Up is funded by the voluntary contributions of Sawnee EMC members to the Sawnee Electric Membership Foundation. Member contributions are made to the Foundation when participants elect to have their monthly electric bill rounded up to the next dollar. For example, a \$70.55 electric bill would result in a total charge of \$71.00 and a 45 cent donation to the Foundation fund. On average, donations are about 50 cents per month or \$6.00 per year. Since Operation Round Up contributions are tax deductible, in January of each year a total annual contribution amount will be provided for your tax records.

Charitable donations are made by the Foundation to worthy projects and needs within the seven-county Sawnee EMC service area. Organizations can apply to the Foundation's voluntary nine-member Board of Directors, who award funds quarterly based on the worthiness of each application and the availability of funds. One hundred percent of funds collected are returned to the community through donations from the Foundation. If you already participate in Operation Round Up – thank you. Each month you join approximately 15,000 other Sawnee EMC members to make a difference in our local communities.






