PATRONAGE CAPITAL



Unlike investor-owned utilities that maximize profits to pay dividends to shareholders, not-for-profit electric cooperatives provide members with "at cost" electric service. At the end of the year, after all operational expenses have been covered, any excess funds are allocated to members. In 2023, we retired approximately \$8 million to members who received electric service from Sawnee EMC during 2005 and/or 2006. This continues to demonstrate that the electric cooperative business model is beneficial and performing well.



ADVANCED ENERGY SOLUTIONS



As your trusted energy advisor, we look for ways to enhance your member experience and in how you view your energy data. To that end, we launched a new online platform of home energy analysis tools through SmartHub. Through these tools you can now see how appliances, like your AC and electric heaters, leave distinct "fingerprints" in your energy data. This new technology can identify these appliance energy fingerprints and estimate how much they cost to operate. This process provides you with personalized, detailed information you can use to save energy and money. 

The 84th Annual Membership Meeting of Sawnee Electric Membership Corporation ("Corporation") was held at the Corporation's Headquarters Facility in Cumming, Georgia, on the 1st day of October 2022.

Mr. Blake House, VP of Member Services, gave a brief welcome and thanked all the members for participating in this important activity of their Cooperative. He introduced Mr. Zack Rice, Jr, Attorney, who presided over the meeting at the pleasure of the Chairman of the Board of Directors, Mr. Gary Porter, and Mr. Tim Heard, Secretary – Treasurer, acted as Secretary of this meeting.

CALL TO ORDER - Mr. Zack Rice called the business session to order at approximately 11:00 a.m. He stated that a total of 491 members had participated in the drive-through registration and since a quorum has been achieved, as required by the Bylaws, it was now in order to consider and transact any and all business that might properly come before the membership, at this time.

At 11:00 a.m. our business session will begin. All times are approximate and subject to vary.




