

Sawnee EMC Announces \$8 MILLION RETIREMENT OF PATRONAGE CAPITAL

Sawnee EMC will soon be refunding approximately \$8 million to over 105,000 active and former Sawnee members through a general retirement of patronage capital. This patronage capital retirement is for all customers who received electric service from Sawnee EMC at any time during 2003.

As outlined in Sawnee's Bylaws, patronage capital is an allocation of the revenue received in excess of operating costs and expenses each year; those funds are then assigned to each member of record for that particular

year.

Active members of
Sawnee EMC, who
received service
at any time during
2003, will receive
their allocated portion
of this patronage capital
retirement in the form of a

"credit" on their March 2021 electric bill. These active members will soon receive a letter, which provides details about this general retirement, including the amount of their refund, as well as a list of frequently asked questions (FAQs).

Former members who no longer have an active account with Sawnee EMC, and who have a valid forwarding address, will be mailed a check to their last known address on or around April 5, 2021. It is important that former Sawnee EMC members notify Sawnee of their

new mailing address when they discontinue electric service.

This helps to ensure that these members receive their future patronage capital retirements.

In addition to the general retirement of patronage capital, it is important to remember that Sawnee EMC also



retires patronage capital to the estates of deceased members. In the past 12 months, approximately 330 such retirements were made, totaling approximately \$409,264. Announcing 2021 Residential Energy Rebates

PLEASE NOTE...The rebates contained herein only apply for work completed in 2021. Please be sure to visit **www.sawnee.com/rebates** for additional information and limitations on 2021 energy related rebates and incentives.

Anytime is a good time to get more energy efficient, but it is even better when a Sawnee EMC rebate can help pay for it. Below is information about the energy rebate programs available to residential accounts for 2021.

INSULATION UPGRADE:

Increase your attic insulation to an R-49 level or greater and receive $\frac{1}{2}$ of the cost, up to \$200. The home must be at least five (5) years old.

SECOND REFRIGERATOR / FREEZER TURN IN:

Replace your second refrigerator or freezer, which must be working and at least 10 years old, with an Energy Star model and receive a rebate of \$30, plus free removal of the old unit. This rebate <u>does not</u> apply to the replacement of the main kitchen refrigerator.

ELECTRIC HYBRID WATER HEATER:

Replace an existing standard water heater with a heat pump water heater and receive a \$100 rebate.

NEW HVAC UNIT:

Replace an existing HVAC unit with a new 17 SEER unit. Please note, the yellow ENERGY GUIDE label located on the outdoor unit must clearly state 17 SEER or greater. Recipients must also agree to participate in one of Sawnee's Load Management programs in order to receive the rebate. Rebate is \$50 per ton.

DUCT SEALING:

Receive a rebate of ½ of the cost, up to \$100, for sealing all accessible HVAC ductwork with mastic.

HVAC TUNE UP:

Receive a rebate of ½ of the cost, up to \$20, for each outside HVAC unit, when you have a "tune up" performed by a licensed HVAC technician. *Tune ups for "gas furnaces only" do not qualify.*

VARIABLE SPEED POOL PUMP:

Replace a conventional swimming pool pump with a variable speed pump and receive ½ of the cost, up to \$100 per pump.

RADIANT BARRIER ROOF DECKING:

Receive a rebate for ½ of total cost, up to \$100, for the installation of a barrier roof sheathing to a home newly constructed in 2021. Rebate does not apply to "roll out" or "paint on" radiant barrier.

NEW FOR 2021 - LEVEL 2 CHARGER REBATE:

Receive a one-time \$250 rebate for installing a Level 2 electric vehicle charger. Must participate in one of Sawnee EMC's Time of Use rates for the required one (1) year minimum period.




TIPS FOR PURCHASING NEW APPLIANCES

When shopping for new appliances, there are two price tags you should consider:





That second price is just as important as the purchase price because you'll be paying for the appliance's energy use for the next 10 to 20 years.



- Look for the ENERGY STAR® label. ENERGY STAR-qualified products exceed the federal minimum standards for efficiency and quality.
- Carefully review the EnergyGuide label on the appliance. The label provides information about how much energy an appliance uses compared to similar models.
- Once you choose your make and model, compare prices. Keep in mind, many retailers will match a lower price offered by competitors.
- Recycle or sell your old appliance. Ask the retailer if they'll pick up your old appliance, or you can sell it yourself. Either option is better than the landfill!

Overnight Cinnamon Baked French Toast

Ingredients:

1 loaf bread (Challah works well)

8 eggs

2 cups milk

½ cup heavy cream

¾ cup sugar

2 tsp. vanilla

½ cup flour

½ cup brown sugar

1 tsp. cinnamon

1/4 tsp. salt

1 stick cold butter, cubed



Instructions:

The night before, grease a 9 x 13 pan. Tear bread into chunks and place in pan. Mix eggs, milk, cream, sugar and vanilla. Pour mixture evenly over the bread. Cover and refrigerate overnight. In a separate bowl, mix the flour, brown sugar, cinnamon and salt. Cut in the butter until the crumb topping is combined. Store this in fridge overnight. In the morning, preheat oven to 350 degrees. Sprinkle crumb topping over soaked bread. Bake for 45 minutes or more until set. This is a sweet casserole and is best served warm. Can add syrup or powdered sugar if desired.
