



Accessing GREEN BUTTON ENERGY Data

If you already access your energy data through Sawnee EMC's SmartHub portal, you should notice a "new" option called "**Green Button**" which provides users a new format to view detailed Sawnee EMC energy usage data. When you proactively review your electricity usage, you can often determine a potential problem before your electric bill arrives.

Use the following steps to access your Sawnee EMC Green Button energy usage data:

- Access Green Button Data in SmartHub, Sawnee's online portal, available at sawnee.
 com. Simply go to "My Usage" and "Usage Management".
- Click the "Green Button Download My Data" button.
- Select the parameters you want applied to your data which can be viewed in your browser, a spreadsheet or on a third-party site that supports Green Button data analysis.

With SmartHub, you have the ability to review and manage your Sawnee EMC account anytime on a mobile device or on the web. Use SmartHub to pay a bill, check energy usage, report service issues and contact Sawnee EMC.

Notice of 2020 PATRONAGE CAPITAL ASSIGNMENT

As a non-profit electric cooperative, all monies in excess of operating expenses which Sawnee EMC receives from furnishing electric energy and ancillary services to its patrons, are assigned annually back to the patrons who provided it. These amounts are referred to as "Patronage Capital" and are used as equity. The funds are invested in the assets of the Corporation – which includes poles, wire, transformers and other necessities to operate the Cooperative.

For fiscal year 2020, each member of record is hereby notified that they have received a Patronage Capital assignment equaling 8.00% of the amount they were billed for electric service during 2020. Additionally, those members have also received an allocation from other cooperatives that furnished electric energy and ancillary services to Sawnee EMC in 2020 equaling 0.56% of the amount they were billed during 2020. Both assignments equal a total assignment of 8.56% of a member's billed electric service.

Each member may calculate the amount of assigned 2020 Patronage Capital by multiplying the total amount billed for electric service in 2020, by the factors shown herein. A sample calculation is shown below.

2020 PATRONAGE CAPITAL ASSIGNMENT

Amount Billed for Electric Service in 2020

Sources	Percentage	\$500	\$1,000	\$1,500
Member's Total Assignment	8.56%	\$42.82	\$85.65	\$128.47

Note: Actual assignment could vary slightly due to rounding and other factors.

2021 COMMITTEE ON NOMINATIONS for the Board of Directors



Sawnee EMC is an electric cooperative governed by its Bylaws, its Charter, Georgia law, and its service rules and regulations established by the Board of Directors. The Bylaws specify certain activities which are reserved for Cooperative members only; the election of Directors to serve on the Cooperative Board is one such activity.

The 2021 Committee on Nominations ("Committee"), which serves a vital role in the affairs of the Corporation, will soon be appointed by the Board of Directors. This Committee will receive input from the membership and determine, as provided for in the Cooperative Bylaws, the name(s) to be placed before the membership, from those members who have met the necessary criteria, to seek the office of Director in the districts with expiring terms.

The Bylaws of the Corporation, in Article 4, Sections 4.02, 4.04, 4.05, and 4.09, outline the director election process, specifically as it relates to the Committee on Nominations. Also, the Bylaws provide for a separate process, outside

of the Committee, known as the "Petition Process" and Information on this process may be found in Article 4, Section 4.09 of the Bylaws.

For 2021, Sawnee EMC has three (3) directorate districts which have terms that are expiring, and they are:

- District #1 (Birmingham)
- District #4 (Dougherty)
- District #6 (Matt)

Sawnee EMC has developed a website to provide members with information about director election activities and district meetings. Interested members should visit **sawnee.com/elections** to review the items relative to this year's activities.

Here's WATTS Cookin' Flamingo Cake

Ingredients:

1 box white cake mix 3.5 oz. package cherry jello gelatin

3/4 cup vegetable oil

3/4 cup milk

3 eggs

8 ounces crushed pineapple 3.4 oz. package instant vanilla pudding

16 oz. whipped topping thawed 8 oz. jar cherries plus some juice



Instructions:

In large mixing bowl place cake mix, gelatin, oil, milk, and eggs. Beat with electric mixer until smooth and well combined, about two minutes. Pour into greased 9x13 pan. Bake at 350 for 30-35 minutes, or until the center springs back when pressed lightly. Allow to cool completely. Prepare icing in medium bowl by adding crushed pineapple, with juice. Sprinkle pudding mix over pineapple and stir with spoon until well combined. Stir in whipped topping until fully incorporated. Chop cherries in half and add along with enough cherry juice to tint the mixture light pink. Frost cake, cover and place in the refrigerator for 2 hours before serving.
